#### I. INTRODUCTION

This report was supported by the USAID-Ghana Sustainable Fisheries Management Project (SFMP) with the aim to assess fisheries enforcement actions and the level of deterrence provided by the State. The reason being that, effective fisheries enforcement is important element for promoting responsible fishing and ensuring that fishers comply with the fishing rules and laws.

Also the key objective of SFMP is to contribute to the rebuilding of Ghana's marine fisheries stock (small pelagics) and catches through *adoption of responsible fishing practices*. Because Ghana's small pelagic species which composed mainly of *Sardinella aurita and Sardinella maderensis*, are the main source of animal protein for the majority of coastal populations. However, the stock has already experienced signs of collapse. Recent stock assessments of small pelagics reported that these stocks are severely overfished and that overfishing continues to exacerbate beyond the level of sustainability.

Towards contributing to the above objective, SFMP places emphasis on law enforcement activities and on shore based fisheries Monitoring Control and Surveillance (MCS) tactics. SFMP has therefore, supported the FEU and the Marine Police with vehicles, workshop materials and series of trainings to equipment them with competence-based approaches to fisheries enforcement and deterrence. SFMP also continue to engage fishing constituencies with intensive behavioral change communication campaigns to promote compliance of the fisheries laws. SFMP is strengthened prosecution chain stakeholders with series of workshops to identify prosecution challenges and resolve them. The tracking of fisheries prosecution cases is therefore one of the ways to assess the enforcement and deterrence interventions of the FEU as well as prosecution to track performance and also identify operational challenges and seek ways to address them.

This report provides an analysis of fisheries arrests and prosecution cases in Ghana from the year 2014 to 2015. The report also analyses the common infractions committed by fishing vessels including industrial, semi-industrial and artisanal canoes.

The data analyzed in this report was obtained from the Fisheries Enforcement Unit (FEU) from both Western and Eastern Command.

However, similar analysis was done in 2015 under the USAID-Ghana Sustainable Fisheries Management Project (SFMP) to prescribe baseline information on fisheries prosecution for the project. In the 2015 baseline report, the data analyzed was from 2007 to 2015 and most of the data used were obtained from the Western command. Therefore, many of the infractions analyzed in the 2015 report were from the Western and Central regions where the FEU western command operates.

This report provides deeper analysis with data from both the Western and Eastern command, in addition new fields that were not available in the 2015 baseline report have been analyzed, including observer reports and infractions beyond Ghana Waters.

#### II. BACKGROUND

In Ghana, the fisheries sector provides employment for about 10% of the population, it also contributes significantly to the GDP of the nation and fisheries is also a foreign exchange earner providing over \$1 billion yearly to Ghana. The fisheries industry also contributes significantly toward food security and the vast number of people engaged in the fishing industry earn incomes that improve upon their access to food, medicine, clothing and other basic necessities of life.

Importantly, fishing is a cultural heritage; it is the way of life and the basic means of existence for most families in coastal and inland fishing zones.

However, Ghana's fishery is near-crisis and recent stock assessments of small pelagics reported that the stocks are severely overfished and that overfishing continues to exacerbate beyond the level of sustainability. This is due to several factors including over-capacitation and increasing fishing efforts, also wide-spread Illegal Unreported and Unregulated (IUU) fishing activities.

Illegal, Unreported and Unregulated (IUU) fishing is a major problem in the West African Region where vessels from other countries or regions are fishing in Ghana's EEZ also domestic IUU fishing by Ghanaian fishers is a concern. Both local Ghanaian fishers and industrial fishing companies are involved in illegal activities, such as transhipment, use of under-size mesh, use of explosives, chemicals, light aggregation fishing, fishing without licence, tampering of vessels monitoring systems, etc.

IUU poses major threat to the sustainability of the fishery sector in Ghana; the resulting depletion of stocks and ecosystem collapse will cause livelihood deprivation for the many communities who depend on the fishery. The result livelihood collapse and poverty has the potential to generate security problems for the coastal zone of the country.

To address the over-capacitation and increasing effort, the Ministry of Fisheries and Aquaculture Development (MOFAD) developed a National Marine Management Plan (NFMP 2015-2019). The NFMP among others proposes several measures to reduce fishing effort. Some of these measures include: reduction of fishing days of industrial and semi-industrial vessels through the introduction of close season, capping of numbers of canoe through registration and moratorium of new entrants, cancellation of license of multiple violator, etc. These and many laudable measures are proposed in the NFMP however, the implementation of these measures cannot be successful without effective enforcement and compliance. Also **voluntary compliance** and **deterrence** is needed to address the wide spread IUU fishing in Ghana.

**Voluntary Compliance**; includes the effort to secure the active support of resource users and their willingness to comply with the necessary legal and regulatory framework and management plans. A key component of voluntary compliance involves carrying along the users of the resource in every step in the decision making and law implementation process.

**Deterrence:** Involves the coercive power of the state to enforce its laws and regulations. Fisheries deterrence includes the exercise of power of arrest, prosecution, adjudication and imposition of sanctions when fisheries laws are violated. Also a key component of deterrence is the show of presence of enforcement agencies or the existence of functional structures that monitor, ensure and maintain a high possibility of arresting violators of the law.

Deterrence also complements compliances to the fisheries laws by fishers as they see law breakers punished. However, where there is low deterrence more fishers join the illegal practices as they perceived that the law breakers are over exploiting the resources at the expense of all others.

Fisheries Enforcement Unit (FEU), is the main unit responsible for fisheries enforcement in Ghana. The unit comprises of Marine Police, Ghana Navy and Fisheries Commission MCS officers. The unit has two (2) operational command post; the Western Command based in Takoradi and the Western Command based in Tema. Both units are managed and controlled from a central supervisor, who provide general operational directives to the unit. The FEU conducts in operations with the marine and inland Volta lake area to provide deterrence and to promote compliance of the laws.

#### III. DATA SOURCE AND LIMITATION

Data for this report were all obtained from the Fisheries Enforcement Unit (FEU) head Quarters in Tema. They were data provided by the unit and there were no means of verifying the data. Also analysis was made on the limited data provided by the FEU, therefore the limitation of the report to analyses wide range of data as desired.

The data requested from FEU were from 2013 to 2017 however, limited data was available for 2016 and 2017 data were not available. The explanation provided was that the year 2016 was an electioneering year and was characterized by low enforcement and the 2017 data was yet to be processed.

#### IV. CATEGORY OF DATA SOURCES

The data analyzed were collated from infractions from the following category of FEU activities:

- Sea Patrols.
- Land Patrols (Beach Combining).
- Vessel Monitoring Systems (VMS).
- Quayside Inspections.
- Fish Observer Missions.




Figure 2. A chart showing the categories of data source for the infractions for the years 2014 and 2015

The chart in Figure 2 below shows the various FEU activities and the number of infractions recorded for each of the activities.

#### V. ANALYSES

The analyses focused on cases handled from the years 2013 and 2017; and were conducted along the following lines:

- Category of Infraction / Violation.
- Vessel Types and Origin.
- Case Settlement and Fine Status.
- Comparative Analysis by year of arrest.
- Rate of compliance.

#### **Category of Infractions/ Violation**

Per the records accessed, the common infractions/ violation were as follows;

- Fishing without license.
- Fishing with light.
- Fishing illegally in foreign waters.
- Use of undersized mesh nets.
- Illegal Transshipment.
- Fishing in IZE (30m depth).




Figure 3. A chart showing common infractions with number of cases

Table 1 below shows the category of infractions and the percentage also Fig 3. Also shows the chart with infractions.

From the table above light fishing by canoes recorded the highest infraction with about 56% of the cases. The high number of light fishing by canoes could be explained by the high number of land patrol (beach Combining) performed by the FEU within the period as indicated in Figure 2.

The next level of infractions was the use of undersize mesh nets recording about 18% of the total infractions recorded.

Fishing in foreign waters without the required license, Transshipment, illegal fishing in 30m depth (IEZ) and fishing without license follow with 10%, 8%, 5% and 3% respectively.

#### **Infractions and Fines Paid**

Table 2 and Figure 3 below shows the infractions and fines paid for the category of infractions recorded.




Figure 4. The fines and payments made

Table 2 and Figure 3 above shows that about 64.69% of fines imposed were paid at the time of this analysis. However, the outstanding 35.31% representing an amount of GHS 1,505,060.00 had not been paid.




Figure 5. A chart showing fisheries infractions and the level of fines and includes what is paid and the remaining not paid




Figure 6 A chart showing the fines for infractions/ violation by Trawlers per year




Figure 7. A chart showing the infraction by trawlers, inshore and canoes in 2014 and 2015

The data in Annexes 1 and 2 are analyzed in the charts below in Figures 4,5,6,7 and 8.

The chart in Figure 5 above shows that illegal transshipment attracted the highest fine of GHS 1,995,745.00 of which GHS 1,622.960 has been paid and a total of GHS 372,785.00 is yet to be paid. The infraction with the second highest fine was fishing without license and this attracted a total fine of GHS 1,837,985.00. The next infraction recorded was fishing in the IEZ and that attracted a fine of GHS 1,439,106.00. Other infractions recorded were juvenile fish, small mesh size nets, light fishing and improper logbook recordings.

Figure 6 above shows total fine paid and the remainder from 2013, 2014 to 2015. From the data there are outstanding fines not paid at the time of this analysis.

Figure 7 shows that the number of infractions by canoes in the year 2014 were 533 as compared with 67 infractions in 2015. Also trawlers had 140 and 70 infractions in 2014 and 2015 respectively.




Figure 8. A chart showing the number of times vessels committed violations




Figure 9. A chart showing Trawler Violations by Year from 2013, 2014 to 2015

Figures 8 and 9, shows the number of times Vessels commits an offense/violation from 2013, 2014 to 2015. This data is very useful for the implementation of the National Fisheries Management Plan (NFMP 2015 -2019) which proposes that fishing license of multiple violators should be cancelled.




Figure 10. A chart showing the violations recorded by location and type from 2013, 2014 to 2015

#### VI. CONCLUSION

From the data collated it could be deduced that most the fine imposed by the settlement committee were less than the prescribed fines in the fisheries laws (Fisheries Act 625 of 2002, the Fisheries Regulations (LI 1968) of 2010) for the same offenses committed.

Also, the Fisheries Amended Act 880 was passed in December 2014 and it prescribes high finds of a minimum of I million Dollars for IUU offense such as: fishing without license, illegal Transshipment, fishing in IEZ, fishing with small Mesh size nets, etc. however, these offenses attracted very low fines from the settlement committee even for case held in 2015 when the Amended Act was in force.

The following are key examples drawn from Annexes 1 and 2.

- Trawler by name Lu Rong Yuan Yu 969, on 26<sup>th</sup> January 16, was caught for using of undersized mesh net, and was fined 6,000.00 by the settlement committee.
- Trawler by name Twin Port City 104, on 5<sup>th</sup> August 2015, was caught for improper use of Top chafers, was fined 12,153.00. by the settlement committee.
- Trawler Meng Xin 2 on 30<sup>th</sup> July 2015, was caught for Improper use of Top chafers, was fined 3,000.00. by the settlement committee.
- Trawler by name Asona, on 30<sup>th</sup> –January 2015 was caught for improper logging and lack of safe boarding and was fined 19,400.00. by the settlement committee.
- Guojin 811, on 23rd January 2015, was caught for Fishing with undersized mesh net, was fined 9,300.00. by the settlement committee.

Not only were these fines very low and below the fines prescribed in the laws but there was a high degree of inconsistency of fines for the same type of offense.

From the data analyzed it is disturbing to realize the level of inconsistency, low fines and the level of outstanding payments yet to be made. Such situation does not portray effective deterrence and demoralizes fisheries enforcement officers in their duties while strengthening recalcitrant fishers to perpetuate illegalities in the sector.

There is the need to therefore, apply proactive measures to review the work of the settlement committee and their fines to address the high suspicion of selective enforcement where only certain aspects of the laws are enforced or where fines are given without the guidance of the fisheries laws.

A fair and effective enforcement program is essential to the sustainability of the fisheries resources. Perception of fair enforcement will promote and complement compliance. Those who violate fisheries laws and regulations not only harm the resources and put the economy at risk; they are unfair to the majority of resource users that comply with the laws.

At least those who abide by the laws deserve to know and feel that violators will be dealt with as prescribed by the fisheries laws and that the standards are unnegotiable.
